integrity of gaming machines / platforms operations within the lottery industry in Liberia. This system is intended to:

- Optimize revenue collection through reliable, accurate, and efficient data capture within the lottery and gambling industry.
- Strengthen regulatory oversight by monitoring and ensuring the integrity of gaming machines and platforms.
- Facilitate anti-money laundering investigations.
- Promote responsible gaming practices, including age verification.
- Detect and prevent fraudulent activities.

The National Lottery Authority now invites sealed bid from eligible and qualified bidders within and outside the Republic of Liberia for the Supply, Delivery, and Installation of a Central Monitoring System for Lottery and Gaming in accordance with the Technical Specifications of this bidding document.
